### EGSi'S POLICY

Some aspects of the company's activities are subject to specific laws and regulations, with which we shall comply fully. Where possible we shall go beyond compliance, endeavouring to use the best practical environmental standards and procedures even in the absence of any legal requirements.

- Share information and experiences with other companies and individuals to ensure effective environmental practices are available for the use of all.
- Demonstrate by our actions, at every level of the company, that EGSi and all its employees are truly committed to pollution prevention and continual improvement while fulfilling the compliance obligations of the company.
